PARTIES

- 1 **THE OLYMPIC DELIVERY AUTHORITY** of 23rd floor, 1 Churchill Place, Canary Wharf, London, E14 5LN (the "ODA" which includes any successor body to the ODA); and
 - 2 **LEE VALLEY REGIONAL PARK AUTHORITY** of Myddelton House, Bulls Cross, Enfield, Middlesex, EN2 9HG (the "Licensor")
- (together the "Parties")

RECITALS

- (A) The ODA and the Venue Owner entered into a licence agreement on 07 July 2011 relating to use of the area known as 'Leyton Marsh' situated at Lea Bridge Road, Leyton E10 7QL for the construction of a basketball facility and as a training venue for the Games (the "**Licence Agreement**").
- (B) The ODA and the Venue Owner have agreed to vary the terms of the Licence Agreement on the terms set out below.

OPERATIVE PROVISIONS

1 **Definitions and interpretation**

The definitions and interpretations in clause 1 of the Licence Agreement are to apply to this deed unless otherwise defined.

2 **Variation**

The Licence Agreement shall be amended in accordance with Schedule 1 (Amendments to the Licence Agreement) to this deed, as if the Licence Agreement was and always had been in the form as amended by this deed.

3 **Continuing application of the Licence Agreement**

Except as varied by this deed the Licence Agreement is to continue in full force and effect in all respects.

4 Governing Law

This deed is governed by English Law.

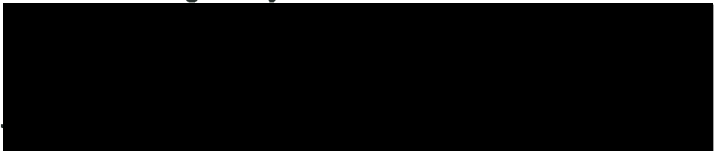
5 Third Party Rights

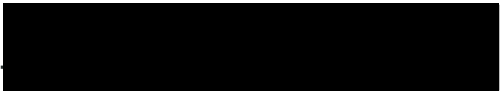

SCHEDULE 1

Amendments to the Licence Agreement
